Beech Street (Multiplan)	Reimbursement is the lesser of 100% of provider's billed charges or the Beech Street Fee Schedule. Beech Street's fee schedule is based on 160% of 2001 Medicare RBRVS for CPT codes with values. The reimbursement for immunizations is 80% of provider's billed charges. In those instances where Beech Street has not assigned a fee, reimbursement will be 80% of provider's billed charges. ACQUIRED BY MULTIPLAN 3/2010. (Effective 4/1/11)
CIGNA	Reimbursement for CPT4 Procedure Code Group (Surgery Codes, Evaluation & Management Codes, Medicine Codes, & Radiology Codes) CCPA's fee is 125% of CIGNA Standard Fee Schedule. Injectables are updated quarterly. In those instances where Cigna has not assigned a fee, reimbursement is a 50% discount off the provider's billed charges.
CIGNA LocalPlus®	Reimbursement for CPT4 Procedure Code Group (Surgery Codes, Evaluation & Management Codes, Medicine Codes, & Radiology Codes) CCPA's fee is 115% of CIGNA LocalPlus fee schedule. Injectables are updated quarterly and will follow the same reimbursement lesser of 100% of provider's billed charges or the CIGNA Standard Fee Schedule.
Cofinity	Reimbursement is the lesser of 100% of provider's billed charges or the Cofinity Master Fee Schedule. The Cofinity Master Fee Schedule is based on 2011 Medicare RBRVS. (Effective 04.15.2012.) CCPA fee is 125% of the Cofinity Master Fee Schedule.
Coventry	Reimbursement is the lesser of 100% of the provider's billed charges or the Coventry Fee Schedule. Coventry's Fee Schedule is based on 128% of 2010 Medicare RBRVS for CPT codes with Medicare values. Laboratory Codes are reimbursed at 100% of 2010 Medicare RBRVS. Preventive Codes are reimbursed at 140% of 2010 Medicare RBRVS. Reimbursement for Immunizations is 85% of provider's billed charges. In those instances where Coventry has not assigned a fee, reimbursement is a 15% discount off the provider's charged amount.
First Health (Coventry Rental Network)	Reimbursement is the lesser of 100% of the provider's billed charges or the First Health Rental Fee Schedule. The First Health Rental Fee Schedule is based on 140% of 2010 Medicare RBRVS for CPT codes with Medicare values. Laboratory Codes are reimbursed at 110% of 2010 Medicare RBRVS. Reimbursement for Immunizations is 85% of provider's billed charges. In those instances where Coventry has not assigned a fee (indicated by "Default"), then reimbursement "defaults" to 85% of the provider's billed charges.
Evolutions	Reimbursement amount is a 12% discount off the provider's charged amount.

HFN Network	Reimbursement is the lesser of 90% of the provider's billed charges or 140% of 2011 RBRVS for all codes. Immunizations are reimbursed at a 10% discount off the provider's charged amount.
Humana PPO	Reimbursement is the lesser of 100% of provider's billed charges or the Humana PPO Fee Schedule. (CCPA's fee is 114% of Humana's standard rates. Immunizations are 108% of Humana's AWP's.) In those instances where Humana has not assigned a fee, reimbursement will be a 25% discount off the provider's charged amount.
Humana ChoiceCare	Reimbursement is the lesser of 100% of provider's billed charges or the Humana ChoiceCare Fee Schedule. (CCPA's fee is 110% of Humana's standard rates. Immunizations are 106% of Humana's AWP's.) In those instances where Humana has not assigned a fee, reimbursement will be a 25% discount off the provider's charged amount.
Independent Medical Systems - IMS (formerly MCS)	Reimbursement amount is a 15% discount off the provider's charged amount.
Interplan Health Group - IHG/HealthSmart (formerly PPI)	Reimbursement amount is a 12% discount off the provider's charged amount.
MultiPlan	Reimbursement is the lesser of 100 % of the provider's billed charges or the MultiPlan Health Network Fee Schedule. MultiPlan's Fee Schedule is based on approximately 140% of the 2008 Medicare RBRVS rates. Immunizations are based on the Multiplan Fee Schedule. For CPT codes with no fee assigned by Multiplan, reimbursement will be calculated as the lesser of 90% of your billed charges or 90% of Multiplan's Usual & Customary charges.
National Preferred Provider Network - NPPN	Reimbursement amount is a 40% discount off the provider's charged amount.
PHCS Savility	Reimbursement is the lesser of 100 % of the provider's billed charges or the PHCS Savility Fee Schedule. In those instances where PHCS Savility has not assigned a fee, reimbursement will be a 20% discount off the provider's charged amount.
PNA	For Primary Care E&M and Preventive Medicine Codes, reimbursement is the lesser of 100% of billed charges or 155% of the current Medicare RBRVS fee schedule. For Pathology Codes, reimbursement is the lesser of 100% of billed charges or 150% of the current Medicare RBRVS fee schedule. Reimbursement for immunizations is a 15% discount off the provider's charged amount. For Specialty codes, reimbursement is the lesser of 100% of billed charges or 175% of the current Medicare RBRVS fee schedule. Reimbursement for codes with no RVU is a 15% discount off the provider's charged amount.
Sagamore	Reimbursement amount is a 12% discount off the provider's charged amount.
USA	Reimbursement amount is a 12% discount off the provider's charged amount.
